Please mail or deliver to the registration office the following information:

- Information form with student signature; parent's signature required for high school student (attached).
- 2 Letters of Recommendation (not from family)
- Letter of intent...your goals, why you are interested in cosmetology, why you have chosen our program.
- High school transcript, copy of high school diploma or GED, or explanation why it is not included.

The cosmetology applications will be due in the registration office according to the following schedule:

Fall Semester	Application deadline: May 1
Spring Semester	Application deadline: October 1
Summer Semester	Application deadline: March 1

Information for you to consider as you apply to the program:

You will be required to complete 2000 hours in order to become a licensed Cosmetologist/Barber. This equals approximately four semesters. (extended hour program)

College Students

- Summer hours: 7:45 - 4:45 Monday through Thursday.
- Regular school year hours: 7:45 - 2:00, optional extended hours to 4:45
- Completed Snow College application (\$30 application fee for new student).
- Under age 22 – copy of ACT scores
- Tuition plus students fees – (See current tuition table)
- Tuition must be paid in full or payment arrangements made in the Richfield cashiers office (\$25 fee) at the beginning of each semester or you will be dropped from classes.
- Additional costs: cosmetology kit, mini-nail kit, trolley, smock and books; approx.\$850
- Financial Aid available – be sure to file early, it takes several weeks to process.

High School Students

- Summer hours: 7:45-4:45 Monday through Thursday
- Regular school year hours: 12:45-4:45 Monday through Thursday
- Completed high school enrollment form
- You will need to have completed enough high school graduation requirements to be released from your high school classes. You will need a 5 hour block for the AM classes or a 4 hour block for the PM classes.
- Letter of Permission form signed by parent and high school counselor
- No tuition costs
- Dual enrollment **college credit** is available for high school students. (Payment of a \$30 application fee is required for new students)
- COSTS: cosmetology kit, mini-nail kit, trolley, smock and books approx. \$850
