# Cost and Payment Deadlines

Your payment covers the following costs:

The price on quad occupancy is \$1250 per person. The price on triple occupancy is \$1350 per person The price on double occupancy is \$1550 per person The price on single occupancy is \$2150 per person

\*All travelers must be dues-paying members of FBLA-PBL for the 2019-20 academic year; cost is \$25 and does not have to be paid by students who have already paid the fee.

The total tour fare shall be paid according to the following deposit schedule:

Deposit: \$750 per person is due 9/17/19 (non-refundable once plane tickets

are purchased)

Balance due: \$500 per person is due 10/4/19 (balance is increased if staying in

room with fewer than four people)

You will make all payments at the Snow College Cashier's office, using the deposit form you are given at the information meeting.

As you prepare for the trip, take into account the extra money you'll want to have on hand. You will need to pay for most of your food, and you will probably want to pick up some souvenirs as well!

#### Limitations

- The official Snow College experience begins when students arrive at the departure airport and ends when students arrive back at the home airport.
- High school students are not allowed to participate in this year's travel seminar.
- Unless a parent/child or sibling relationship, Snow College strongly recommends that all room occupants be the same gender.
- Students, faculty, staff, and guests traveling with our Snow College delegation will be expected to act in accordance
  with the Snow College student code of conduct (no alcohol; disorderly conduct; breaking park, airline, tour rules; etc.).
